

“zMAX SWEEPSTAKES”

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

ELIGIBILITY: To enter the “zMAX Sweepstakes” (“Sweepstakes”), you must, at the time of entry, (i) be a legal citizen of the United States and the District of Columbia, (ii) be 18 years of age or older, and (iii) be physically located in the United States or the District of Columbia. HOW TO ENTER: Visit zmax.com/giveaway and click on the link to the official online entry form for the Sweepstakes (the “Entry Form”). Complete the Entry Form in its entirety by providing all required information and submit your Entry Form in accordance with the on-screen directions (hereafter referred to as “**entry**” or “**entries**”). There is a limit of one (1) Entry Form per person and per email address. Any use of automated, robotic, macro, programmed or similar quick-entry programs, attempts to exceed the maximum number of entries permitted, or use of more than one (1) email address per entrant, is prohibited and will result in disqualification.
